Punkt 5: Approval of revised study regulation for the Master programme in Socio-Economics

The study board is asked to comment and approve the revised study regulation for Socio-Economics.

Major changes:

The structure has been changed in order to:

- see to it that profiles in the programme are mainly sharpened in electives and projects - there is no longer a difference between the second and third semester depending on profile chosen. Reason: too few students to make the programme financially viable.
- reduce costs by reducing the number of exams by testing 3 mandatory sub-courses of 5 ECTS in one course/exam of 15 ECTS.
- have only two study elements in the third semester if the student chooses a project-oriented internship.

Beslutning

There was a discussion about the new 15 ECTS course consisting of three sub-courses. The board appreciates the need to reduce costs but the board is not in favour of such a big exam. If financially possible at a later time, the board would like to revise this kind of cost saving actions.

Otherwise the changes to the study regulations were approved.

Beslutning

Comments:

- There is a worry that specialization is lost - especially in 75 ECTS programmes - if courses are to be 10 ECTS rather than 5 ECTS in order to save costs concerning exams (fewer exams).
- In general, the study board is not in favour of combining exams/courses. Not enough time to show what you have learned and a small mistake may have a huge effect.
- The exam committee should not have opinions about how the three first semesters of the bachelor programme should be planned. Study boards are responsible for pedagogical aims.
- Better ideas about AI are lacking.
- Ideas:
 - Maybe one oral exam for several take-home assignments? With as many grades as assignments.
 - Combination of specialization courses in one module with one exam.
 - When combining courses in one exam: demand that everything is at least passed.
- Concerned that diplomas/transcripts will not show the competences of the students.
- Rather reduce number of exam forms than number of exams.
- Too early to decide before the master reform. We should have exam forms that are useful in the new programmes. Potential mismatch between exam forms and new programmes.
- Specialized enough to be employable - how to? Profiles in masters + more specialization at BA level.
- One exam form mandatory courses is ok.
- Variation in exam forms needed. Will be assured with the new catalogue
- Fewer exams forms but we need flexibility.
- Exam forms + sub forms evaluated over the fall - fine.
- AI: agree. Except for formulation skills. Proof reading or rewriting? Needs to be specific. What could be acceptable prompts?
- The study board wishes to keep the demand for good formulation stay but agrees that it does not make sense to demand spelling or grammar skills - Word already provides that.
- Home assignments: the study board is fine with only two formats 48 hours, 1 week.
- The number of home-assignments should be a decision for the study board - also as part of assuring variation in the exam forms.
- Why would a tool be necessary to know the cost of an exam? We know what is expensive and what is cheaper.
- Initiatives concerning digitalization and surveillance of invigilated exams are supported.

Mette Apollo has asked for and received input from Bangladeshi students as to what they think could be improved concerning the BAL programme to retain/better accommodate Bangladeshi students.

Beslutning

Important points from the Bangladeshi students memo:

- For the Bangladeshi students, it takes the better part of a semester to learn to be a RUC student.
- The concept of plagiarism is difficult to understand
- Being used to high power distance, the students experience problems handling a low power distance

Mette about initiatives during study start relating to the topics of the memo:

- This semester, at the Foundation course, EØ does a lot of the course ourselves and thus we decide how we plan to convey information
- There will be a re-running of Stefan's, Mette's and John's speeches during the study start
- How to RUC has been improved and provides all of the information the students ask for in the first paragraph of their memo
- There will be a speech by a Bangladeshi student on how to be a part of the RUC study environment

Comments:

- Also more effort from the students' part. They are master students, not bachelor students.
- Concerning the academic level of the students, it seems that some of the universities that the students come from are not universities in a European sense/tradition.
- In the memo, the students suggest that they are given good examples of earlier projects. The VIP members of the board much prefer to hand out templates and talk about how to fill them in.
- Innovation management has actually put an example on Moodle but the students did not use it/learn from it
- Help the students know that it is allowed to not accept "free riders".
