Punkt 4: Orientation about the next UDDU-meeting

The next UDDU-meeting will be on 7 January. On the agenda is the upcoming BA-reform.

Beslutning

The next UDDU-meeting is expected to be held on 7 January and be about the upcoming BA-reform. A meeting with this topic has been called and cancelled several times.

It is unclear how broad a discussion UDDU can have; the process is unclear as well.

To have an input ready for the meeting, the BA Heads of Studies have gone through their IUE (internal evaluation of programmes).

Punkt 5: Orientation about new way of listing exam types for electives

The central admin has gone over the study regulations for SIB and SAB to simplify them. Not content-wise, only presentation-wise.

The result of this is that in stead of describing the elective options (exam type) one by one, they have been grouped by oral and written examinations.

The full, new text can be seen in the appendices in English. The present, Danish text will be organised likewise for SAB.

Recommendation

It is recommended that the study board decides that:

- For all portfolio exams on all its programmes the re-exam type is changed from “Same as ordinary” to a portfolio exam where all products are written **after** the course. (If the ordinary portfolio exam for a course already has that formulation, this of course does not apply.)
- The character limit is the same as for the ordinary exam.
If there are character limits for the different products, they are to be written on Study.ruc.dk. For BA-courses in the field “Detailed description”, for MA-courses in the field “Examination and assessment criteria (implemented)”.
