Beslutning

The study board discussed the survey and made the following points:

- Student feedback on the social aspects of the study environment on SIB and SAB are doing worse both in terms of comparing 2023 and 2021 and compared with the other departments' BA programs. Though, it is expected that current initiatives concerning Max WeBar, the initiatives surrounding the project formations, and the environment around the buildings in the swamp will have a positive effect.
- There is a continued wish from students to have rooms and locations that are completely their own.
- Interest and learning motivation has gone up and is higher compared to the rest of RUC.

The study board went through key numbers on, e.g., admission numbers, drop out rates, among others:

- Helene noted that the future cap on SIB at 105 students is welcomed in the perspective of head of study as it will make planning the program more manageable. The 2024 intake was 153 students. There will be no cap at SAB
- "Langt frafald" (dropout on 2nd and 3rd year) are relative high for SIB but there might be some structural and personal financial issues to explain this.
- The ISE subject modules experiences a fine intake of students from other departments.
