Punkt 12: Drop-out analysis - 25 min.

RUC's drop-out analysis

The dropout Analysis 2025 is an analysis of dropout patterns among Roskilde University students enrolled between 2015 and 2023. The analysis is conducted every two years and is one of the key analyses carried out at Roskilde University. The purpose of the analysis is to contribute to further efforts to reduce dropout rates. The report is in Danish. There will be a short presentation at the meeting of the main conclusions on RUC-level at the meeting.

The study board will only focus on two additional STADS-data reports concerning the INM master programmes. The reports concern first year drop-out and long time drop-out.

About first year drop-out and long time drop-out (see appendices)

Report on 'førsteårs frafald'/first year drop-out:

- concerns the student years/optagsårangange 2020-2024
- definition: students who drop out within the first year of study

Report on 'langt frafald'/long time drop-out:

- concerns the student years/optagsårangange 2019-2021 (the master programmes before 2022)
- definition: students who drop out during first 3 years of studies (normeret tid + 1 år)

Task

The study board will look at the numbers/2 reports together to find out whether we can identify patterns/things that could help us understand if and where students might be struggling.
