Punkt 4: Approval of recommendations of changes to the study regulation (9.45-10.15)

Recommendation

It is recommended that the study board

- Familiarizes itself with the timeline for the changes to study regulations with effect of E26
- Decides on the suggested changes to study regulations

Background

As every year, the study boards have the possibility to make changes to study regulations suggested by themselves, a Head of Studies or a course convenor.

Due to AI challenges, this year, a number of course responsables across ISE have suggested that their course has a written invigilated exam instead of the present exam type.

This makes a lot of sense but unfortunately RUC does not have the resources to go through with it. The programme Observer (used for checking that the students are online but only use the internet for down- and uploads of the exam assignment) requires the presence of staff from Tilmelding og Eksamen/Registration and Exams at invigilated exams and they simply do not have the hours to cover more invigilated exams then we already have at RUC.

This means that the course convenors must choose another alternative if they do not wish to keep the exam type, they have now. This message has been conveyed to them, and they have a new deadline (17 November) to propose another exam type.

Beslutning

The board considered a series of changes across programmes and course modules. For Fagmodulkursus 4a/4b/7 – videregående samfundsvidenskabelig metode, the changes were approved; however, the board requested a re-opening of the exam catalogue to reconsider the exam types.

For Subject module 4a/4b/7 – advanced social science methodology course, the changes were approved with an editorial adjustment: the phrase “professional level” should be revised to “expected academic level of the course”, and the word “to” should be deleted in the relevant sentence.

Subject module course 2: Organisation Theory was rejected in its proposed form and changed to a portfolio assessment.

Subject module course 3: Marketing Management was approved.

Videregående organisering og forandring, the preferred solution is a written invigilated onsite exam; if this is not approved, the alternative is an oral group exam with a written product (synopsis).

Advanced Organisation and Change, the preferred solution is likewise a written invigilated exam; if not feasible, the alternative is an oral group exam with a written product (synopsis).

Advanced HRM, the proposal was approved.

Fagmodulkursus 4: Makroøkonomi was rejected in its proposed form and changed to a portfolio assessment.

Fagmodulkursus 7: Økonometri was rejected and changed to a portfolio.

Advanced Macroeconomics and Advanced Econometrics was rejected in their proposed form and changed to portfolio assessments.

Green Macro-Finance was approved.

The board asked for a broader discussion of the exam catalogue at a future meeting and for teachers to be included in that dialogue. The proposed portfolio re-exam was rejected; the board's alternative is a written product after the course with an oral exam, retaining the same character traits and scope as the portfolio.

The external examiners' corps considered RUC's learning outcomes exemplary, and the board therefore does not concur with comments suggesting that the learning goals should be simpler—though reformulations may be considered. The board emphasized that exam conditions are not at a satisfactory level and should be improved at management level. The service level when hosting external examiners must at least match that of other Danish Universities.
