Punkt 4: Rektor's decision in chatGPT exam cheating

Beslutning

Helene orientated the study board about rector's decision regarding a cheating case from February regarding a SIB student. Few other cases across RUC have come up later as well. Rector has decided to have the student expelled from the university.

The central administration conveyed to ISE's heads of studies last week that rector has deliberated upon the issue quite a bit.

The study board discussed different questions and aspects related to the use of AI/LLM and what constitutes cheating. ChatGPT is not allowed to be used in exams unless explicitly provisioned.

Punkt 5: No support from secretariat in October, November & December

Beslutning

Helene gave notice that Camilla and Sofie leave ISE by November 1. The education support team will thus only consist of Helle and a student assistant, who handles allocation, while Andres is on paternity leave until February 6.

Postings for new hires have been publicized, but the level of service to the study board and the heads of studies at ISE will be quite low for the next couple of months.

Punkt 7: Retention and drop out initiative - Inaktive studiets

Beslutning

Helene informed the study board about the ongoing work to retain students in danger of dropping out or showing signs of inactivity.

- *Kriminelle fællesskaber i udsatte boligområder*: elective course by Hakan Kalkan that used to run and was quite popular with around 40 students. The study board supported to offer it again.
- *Economic frontiers in Science Fiction*: elective course by Kristine Samson and Ali Riza Taskale. The study board supported to try to have it offered across all the BA degree programs at RUC.

Beslutning

- Bachelorprojekt (Socialvidenskab): "Tilrettelæggelse og indsats" is not the same as the others. The study board agreed that it should be made the same. Helene will alter the text.
- Basiskursus 6: Kvalitativ metode: everything should add up to 135 hours. Helene will email Catharina about making the change.

Decision: The study board approved the course descriptions with the above mentioned changes.

Punkt 11: Proposed changes to study curriculum: BK7 videnskabsteori, BK5 Plan, rum og resurser and Analysestrategi (orientation)

Beslutning

The study board processed the proposed changes to the study regulation for the mentioned courses:

Basiskursus 7: Samfundsvidenskabelig videnskabsteori.

The course convenors have written a new book that will make new learning goals more appropriate. The learning goals have been developed in collaboration with EAE, the central unit of pedagogical and didactic development at RUC.

The study board made the following comments:

- "Aksiologi" is difficult to understand, it needs to be elaborated upon; the section lacks the mention of "methodology".
- "Færdigheder": it needs "viden om/at undersøge" before "en given problemstilling". "Ligge" needs to be changed to "lægger".
- "Tilladte hjælpemidler": it needs to be elaborated that the students are allowed to have a printed version of their assignment.

Basiskursus 5: Planlægning af plan, rum og ressourcer.

A new course description and new learning goals were proposed.

The study board made the following comments:

- The course description is too long and needs to be revised. But it is better than the previous one with more coherence and the course's relevance for SAB and SIB is clearer conveyed.

Analysestrategier (SAB)/Analytical strategy (SIB):

The course convenor wants to make changes in the exam form with shorter student presentations to allow for more dialogue between the examiner and the students.

The study board made the following comments:

- "Maximally" should be deleted as 2 minutes already is quite short.
- "Presentation" should be changed to "pitch" to underline what the 2 minutes talk is about.

Decision:

The changes will be formally approved on November's meeting after the course convenors have made the required changes. Helene will convey the study board's comments to the course convenors.
